

Under the scheme of Intellectual Property Education, Research and public outreach (IPERPO), Ministry of Human Resource agreed for setting up of MHRDIPR chair at National law University, Jodhpur.

A number of IPR research and learning initiatives including IPR awareness programs, formulation and conduction of various undergraduate and postgraduate IPR Courses, research and suggestions on IPR Law Reforms and IPR Policies are the core functional areas with in the scope of IPR Chair.

*Appraisal report for the duration (April, 2013 to March, 2014) is as follows:*

**1. In training of trainers (April 23, 2013)**

Dr. (Prof) Madhukar Sinha, Indian Institute of Foreign Trade, New Delhi gave lecture on "Economics of Copyright" and Economics of IP and Competition Policy" to the teachers and researchers in the field of IPR.

**2. In 2013 Workshop arranged for students on 'IP Litigation' (5<sup>th</sup> October 2013)**

**Abstract**

Intellectual property is the property created by the intellect of human mind which encompasses the protection offered by the legal regime of various types like Patent, Copyright, Trademark, Designs. Intellectual property as a proprietary right is limited in its scope and duration. Human intellect and organizational capabilities play a crucial role in R&D and Economy; this is forcing us to rethink intellectual property rights.

This challenge is crucial in the case of Copyright as compared to other IP rights. The protection of copyright and related rights covers a wide array of human creativity. The proliferation of digital technologies and entertainment industry, and changed economic policies has added a new dimension to the question of how to maintain a balance between the protection available to right owners, and the needs of specific user groups. Copyright Amendment Act, 2012 has initiated some changes which have short term and long-term effects on the digital and entertainment industry.

Madrid Protocol has initiated the International Registration of Marks at the World Intellectual Property Organization (WIPO) and thus helped in Protecting Trademark Worldwide by using the Madrid System. India has joined Madrid Protocol and getting the advantages of it. Madrid system provides the trademark owner a chance of having his trademark protected in more than one member country of the Madrid system through a single application, in a single language (English or French), with a single set of fees, in one currency (Swiss Francs). As a result the

trademark owners of India will be able to get protection not only in Indian market but also in ninety other member countries through a single application. Because of the benefits resulting from the Madrid system, large business entities as well as SMEs are attracted. There is a strong growth in demand for IPRs in India, thus this Protocol is welcomed by Indian companies by which they can get registration of their trademark in any or all of the member country. India's trademark litigation process is facing the impacts as a result of implementation of Madrid Protocol.

Understanding the intellectual property rights is critical for protection and commercialization of innovation. Global trade becomes a considerable contributor to the revenue and growth of businesses, and companies are learning to export their products to foreign markets. During current challenging global economic situation, companies must persistently do innovation and try to explore new markets. A thorough knowledge of the IP landscape is crucial for strategic placement of patented products. Patent related industries ranges from pharmaceuticals, life sciences, IT, ICT, telecoms, semiconductor, electronics, to food and beverage, automotive, transport and other industries. Scenario of patent litigation is also ever changing with the advancement in technology.

The objective of this workshop is to enhance the knowledge of undergraduate and post-graduate IPR students, as this workshop will address the legal and practical perspectives of IP litigation in India to deal with the challenges nationally and internationally.

### Speakers and Abstracts of their Discussion

Ms. Richa Pandey, Advocate & Partner, Krishna & Saurastri Associates – ‘Challenges and Current position of Patent litigation in India’, She commenced the session by mentioning the basic framework and constitution of the Intellectual Property Appellate Tribunal (IPAB), the hierarchy of the courts in patent infringement and revocation proceedings. Further, she discussed the various landmark decisions rendered by higher courts of the country viz., *Novartis Glivec Case*, *Roche v. Cipla*, *Bayer v. Cipla*, *Bayer v. Natco* highlighting the approach of the courts- which has largely kept “public interest” in mind- while interpreting the various sections of the Patents Act. In her concluding remarks, Mrs. Pandey highlighted the need for specialized intellectual property courts since there is lack of expertise in judiciary especially with regard to patent matters.

Ms. Anusuya Nigam, Associate, Singh & Singh – ‘Challenges and Current position of Trademark litigation in India’. She provided an overview of the litigation process and the different stages involved in it. Further, the emerging issues in trademark litigation like unconventional trademarks, well known marks, trademarks in the age of internet, interface between trademarks and designs and advertising issues were also highlighted during the discussion. The speaker made an evaluation of the challenges surrounding trademark litigation like jurisdictional questions, investigation delays, problems in filing of originals, procurement of evidence and adjudication of technical issues.

### 2. One day Conference on ‘Impact of IPR on Access to Medicine’ on 22<sup>nd</sup> February, 2014.

#### Abstract

Health for all is an idealistic goal for all countries, more so for the developing countries as it is evident that the number of people affected by life threatening diseases like HIV/AIDS, malaria, tuberculosis, cancer are constantly increasing and the cost of the medicines which can treat these diseases are far beyond the limited capacity of affordability of the vast population of developing and least developed countries. Main issues are (i) the stipulated medicine is not reaching to the patients; (ii) pricing of the medicine is beyond the capacity of the patients; and (iii) the countries are struggling hard to remove the obstacles.

There are many obstacles for access to medicine and price of medicine is one of the important one. Especially the price of the patented drugs is extremely high. Generic version of the same drug is available at much cheaper price in the market. International bodies like WHO, UNITAID; international NGOs like Clinton Foundation and Medicines Sans Frontiers and national governments trying hard to make the medicines available to the patients. Brazil, for example, has made the treatment for HIV/AIDS completely free for all its patients. Poor socio-economic conditions of developing and least developed countries are the cause of these communicable diseases. On top of that, if the national governments have to spend a lot of budget in making the patented drugs available for the patients then social improvements in the aforesaid priority areas will be minimized; and thus it will be a vicious cycle which is devastating and detrimental to the mankind as a whole.

Access to medicine is a complex area of research having interphase between diverse areas of legal provision. In the one hand it includes IPR issues namely patent protection which is clearly covering two diverging area of importance, (i) it provides incentives for future research and development in pharmaceutical sector by providing exclusive rights to the patent holder for a limited period of time and (ii) strict patent law results in price rise for essential medicines and delays the affordable generic version of drugs to enter into the market. Not only patent but also allied legal provisions increasing market exclusivity has direct relation and enormous impact on the issue; those provisions includes data exclusivity, patent linkage, incremental innovation, evergreening etc. Implementation of these provisions in different national legal regime is necessary to find out the actual implication of these provisions on the access to medicine. Provision of competition law also has to be analyzed to comprehend the anti-competitive practices and to make out international policy guidelines to minimize the same.

Theoretically the provisions of compulsory licensing and the parallel import sounds relatively good options to cope up the problems related to access to medicine specially those associated with the patent protection. But in reality the situation is different.

So, access to medicine is a serious concern for every developing and least developed countries, position of India in recent time is a prime focus in global arena. Different international organizations are actively participating in the debates and negotiations regarding cost of medicine to make the drugs affordable for the poorest of the patients. Differential pricing or tiered pricing system, patent pooling, voluntary licensing, open source drug discovery system, using alternative medicines instead of patented drugs (some active measures are taken in India by AYUSH) are some examples of newer forms of suggestive solutions which is thought of and tried to be executed by the international activist organizations like MSF, UNITAID, Clinton Foundation and so on. There is a need to discuss the different IPR issues which is hindering access to medicine, not only that there is a need to examine pros and cons of different aspects to analyze the current and future position of access to medicine. Each and every aspect mentioned above need critical analysis to reach a transparent and clear understanding of the barriers for access to medicine and to find out a way forward for removal of those barriers.

#### Speakers and Abstract of their Discussion

The conference on "Impact of IPR on Access to Medicine" in collaboration with "Indian Council of Medical Research" (ICMR) was held on 22<sup>nd</sup> February 2014. Mr. K.K. Bannerjee, Dean, Faculty of Science, giving the welcome address initiated the discussion by introducing the theme of the conference. This was followed by the inaugural address by Professor I.P. Massey, Dean, Faculty of Law who highlighted that access to quality and affordable medicine is a basic human right which every individual has an inherent right to avail. The first two speakers of the first technical session, Dr. K. Satyanarayana and Dr. Sadhana Srivastava, of the ICMR addressed the interface of the TRIPS regime and public health in India. Dr. Swati Bal Tembe, Former Vice-President, Piramal Healthcare Ltd, on the topic Product Patent Regime And Incremental Innovation. She recommended to set-up a hybrid model involving public funding, public-private partnerships, corporate social responsibility, philanthropy and drug donation. Miss Leena Menghaney, Campaign Coordinator, Medecins Sans Frontieres (MSF) International, concluded the first session by highlighting that to understand differential pricing of drugs it is important to do a comparative study of views in different jurisdictions. The second session was flagged off by Dr. Navneet S. Tewatia, Programme Officer, United Nation Office, Delhi who spoke on implications of data exclusivity in Indian pharmaceuticals industries. IP and Competition issues were addressed next by Mr. Tahir A. Siddiqui, a practicing advocate in the Delhi High Court. He felt that CCI can be helpful in bringing about

coordination between different regulatory agencies to plug loopholes in the pharmaceutical supply chain. The last speaker, Dr Gopakumar Nair, gave a brief idea on the strategies adopted by the Indian pharmaceuticals and said that new entities which were coming from abroad have slowed down the industry. On a concluding note, Dr. Nair urged the Indian Pharmaceutical companies to take note of faster growth that has been achieved by countries like China, Korea, Indonesia, Brazil, etc.





### Activities Proposed to be undertaken from April, 2014 to March, 2015

#### **(1) IPR awareness, training, sensitization, outreach activities:**

We propose to organize two outreach programs to spread IPR awareness amongst the holders and creators of IPR in collaboration with prominent national level Institutes like IIT, AIIMS, ICAR, FDDI, NIFT etc. in Jodhpur.

#### **(2) Academic Research in theory and application of IPR:**

(i) Towards achieving the objective of academic research as set by the norms, a system of a system of publishing papers in areas of law and policy of intellectual property rights is in existence. One recent case comment on Association for Molecular Pathology, *et al v United States Patent and Trademark Office et al* which is published online at Rostrum's Law Review Volume I Issue IV and can be accessed at <http://www.scribd.com/doc/240ostr03379/Rostrum-s-Law-Review-Vol-I-Issue-IV>. Some more research papers are going to come in coming academic year.

(ii) Regular research activities by students of UG & PG courses in terms of Essay Competition and Moot Court Competition related to IPR.

(iii) Proposed online journal on IPR.

#### **(3) Extended Research support for Government of India:**

(i) As per "General conditions for grants" the MHRD IPR Chairs are expected to provide policy advice to the Ministry in different IPR matters, it is suggested that this should be one of the major activities of the IPR Chair at NLU, Jodhpur. Both national and international law and policy work in all areas of IPRs should be considered. In fact the MHRD IPR Chair at NLU, Jodhpur is closely working with the Ministry on the issues of Consolidated Views on Draft Articles as Drafted by WIPO for 28th Session of WIPO Intergovernmental Committee (IGC) on Intellectual Property and Genetic Resources, Traditional Knowledge and Folklore which is scheduled to be held at Geneva from 7-9 July, 2014.

(ii) Proposed research paper is coming on Critical Analysis of Indian Design Law.

#### **(4) Workshop:**






