1	Please indicate in detail the process followed by Department of Industrial Policy and Promotion for the constitution for an IPR Think Tank to draft the National Intellectual Property Rights Policy under Public Notice No.10 (22)/2013-IPR-III dated November 13, 2014.	This Department convened an interactive meeting on IPR issues on 22.09.2014 under the Chairmanship of the Minister for Commerce and Industry(Independent Charge) with a view to discuss the issues related to IPRs, including finalization of the Terms of Reference for IPR Think-Tank proposed to be established. In the said meeting, the representatives from various Ministries/Departments, Member of various Expert Committees constituted by the Department, besides IP experts and other Legal Practioners, were invited. The composition of the IPR Think-Tank was decided on the basis of the discussions held in the department after the said interactive Meeting.

**Minutes of the Interactive Meeting on IPR Issues held on 22.09.2014 at 4:00 PM in Conference Room No 47, UdyogBhawan, New Delhi.**

An Interactive Meeting on IPR Issues with representatives of various Ministries/Departments, IP experts and legal practitioners was held under the Chairmanship of Smt Nirmala Sitharaman, Hon'ble Minister of State (Independent Charge) for Commerce and Industry on 22.09.2014 at 4:00 PM in Conference Room No 47, Udyog Bhawan, New Delhi. A list of participants is placed at **Annexure-I**.

2. At the outset, Shri Amitabh Kant, Secretary, Department of Industrial Policy and Promotion welcomed all the participants. Referring to the recent announcement made by the Hon'ble MoS(I/C) on formulation of the National IPR Policy and to establish 'IPR Think Tank', he stated that this meeting had been organized to discuss on various IPR issues with IP experts and legal practitioners so that it would provide essential inputs to the policy needs of the department. He said that the objective of this department is to have a world class IP system which includes a comprehensive National IPR Policy which takes care of various issues like IP creation, protection, administration and capacity building. He also said that it was necessary for government to interact on these important policy issues with IPR stakeholders and get their considered inputs.

3. In her opening remarks Hon'ble MoS (I/C) informed that the purpose of calling this meeting is to constitute an IP Think Tank that could regularly provide inputs to all IP policy needs of this department as well as advice government in disparate legal aspects. Hon'ble Minister said that it is imperative to have such interaction with IP experts and legal practitioners so that a comprehensive National IPR Policy, whose framework could address all aspects of IPRs, could be finalised. Hon'ble Minister emphasized the need of seeking the views and comments of all state governments also on the proposed National IPR Policy. Hon'ble Minister urged the participants to discuss 4 or 5 key areas in IP and based on their inputs the department could come out with a draft National IPR Policy in the next 90 days.

4. Thereafter, the participants were invited to express their views on the various IP issues of the meeting. After detailed deliberations, the following issues emerged during the above discussion:

- i. The proposal to constitute an IP Think Tank is a welcome step as similar initiatives already exist in Australia, South Korea, the UK and the US.
- ii. Indian courts have given many favourable judgments to foreign IP stakeholders and MNCs and these developments have to be highlighted to project strong IP enforcement in India. This could be done by bringing out



- papers containing analysis of these judgments which can ultimately remove misconceptions nursed by various foreign stakeholders about Indian IP regime including enforcement.
- iii. To bring out white papers on major IP issues to clarify the legal aspects and also
  - iv. There is a need to revise the law on Geographical indications.
  - v. The national policies on telecom, manufacturing and IPRs have to be integrated. The approach should be holistic with major focus on the national priorities and of the state government.
  - vi. The focal point of the National IPR Policy should also be on increase in creation of IP including commercialization of IP and strengthening human capital and IP management.
  - vii. The National IPR Policy should include protection of traditional knowledge and it should include guidelines on publicly funded research. Empirical studies have to be conducted on feasibility of introduction of Utility models.
5. In response to the above, Hon'ble MoS (I/C) opined that it is imperative to decide the areas and sub-areas to be covered under the proposed National IPR Policy. She enumerated 6 major areas emerged during the discussion namely, IP institution, legislation, implementation, public awareness, international aspects and barriers in IP growth. Hon'ble Minister requested all the participants to provide their comments on the framework of the National IPR Policy by 30<sup>th</sup> September 2014. Hon'ble Minister also proposed that another inter-ministerial meeting including IPR experts and legal practitioners would be held to discuss the framework on the proposed National IPR Policy around 10<sup>th</sup> October, 2014.
6. The meeting concluded with vote of thanks to the Chair.
