



The IPR Chair in the Department of Legal Studies, University of Madras was established in the year of 2001 and it has been in an active state. As desired by the MHRD after getting prior permission from the University Syndicate a separate Savings Bank Account was opened in the State Bank of India, Madras University of Madras Branch with the SB Account Number: 31092857842.

Now, the IPR Chair is fully operational.

**1. Appointments**

As per the guidelines of MHRD for IPR Chair Mr.P.R.L.Rajavenkatesan who obtained LLM from the Cochin University of Technology is appointed as Senior Research Fellow from 01-12-2010 and he has awarded Ph.D in the Month of August-2012. Mr.Sivakumar S who obtained M.L. Degree from the Department of Legal Studies is appointed as Junior Research Fellow from 01-12-2010. Dr.G.Rajasekar is appointed as Research Officer from 01-01-2011. The Activities of IPR Chair is carried out under three major areas viz; IPR-Teaching, IPR-Research and IPR- Out Reach Programmes.

**2. IPR Teaching**

As a part of IPR Teaching, under the Choice-Based Credit System (CBCS) an elective Course Introduction to Intellectual Property Rights is offered to the Department Students and Other Department Students in the Third Semester. Master of Law Students is encouraged to Select IPR related areas for their Dissertation. Thus the research in IPR is encouraged in the post Graduation Level. IPR research at Ph.D Level is also carried out. In fact two students have been awarded Ph.D in IPR in the Department.

### **4. National Seminar on IPR**




