Re: Information required on the Laws, Policies, Programmes, schemes and other initiatives for Persons with Disabilities in NCT of Delhi.

As mentioned in our earlier communication, the Centre for Internet and Society, an independent non-profit research organisation based in Bangalore, is engaged in a project to compile a National Resource Kit on various laws, policies, programmes, schemes, notifications, circulars, etc., which have been created for persons with disabilities in all states and union territories in India<sup>2</sup>. The project is supported by the Hans Foundation, a charitable trust fund created to provide a source of endowment for not-for-profit organizations in the areas of disability, education and health care.

We have compiled the details of schemes and programmes available for persons with disabilities in Delhi from the website of the Social Welfare Department and few other sources and have produced The NCT Delhi chapter that provides information on the laws, policies, programmes and schemes for persons with disabilities in the NCT of Delhi (attached with this letter). We require the notification numbers for the schemes that are included in the write up. Please find below the list of schemes for which notification numbers are required.

2 ✓	3% reservation in ITIs for students with disabilities
3	3% reservation to Grade C & D state government posts in direct recruitment
4	10 years age relaxation for applying to state government posts

6	Centres identified for issuance of disability identity cards
7	Hospitals for issuing disability certificates
8 ✓	Financial Assistance Scheme 2009 for persons with disabilities under the age of 60 years
9 ✓	Scheme for Old Age Assistance for persons with disabilities above the age of 60 years
