If so, please provide a copy of such order or order.

Answer 1: Department issued directions to block 32 websites on 18-12-2014 based on the request of ATS, Mumbai as they were being used to post information related to ISIS using the resources provided by these websites. These links were appearing and disappearing on a regular basis. Attempts were made to contact the websites, however websites replied only after the blocking of objectionable contents. After obtaining undertaking from the website owners on 09-01-2015 that they would work with the Government to comply with Indian Laws, the sites were unblocked and have been accessible in the Country.

Further, as per the provision of Rules 16 of the Information Technology (Procedure and Safeguard for Blocking for Access of Information by Public) Rules, 2009, notified under section 69A of the Information Technology Act 2000, the request and complaints received and actions taken thereof are strictly confidential.

Question 2: If not, What action been taken by the Department for blocking of websites or requesting takedown of content from Facebook or Twitter in contravention of any provision of the IT Act? If so, what was the Information that was ordered to be blocked?
