ON TECHNICAL COOPERATION

IN THE FIELD OF SUSTAINABLE URBAN DEVELOPMENT

The Agence Française de Développement, a French public entity governed by French law, and the Government of the Union Territory of Chandigarh, of the Republic of India, (hereinafter referred to as « The Parties ») hereby acknowledge the following:

- that an Indo-French bilateral cooperation agreement has been signed on 5 October 2012 in the Recognizing: domain of Sustainable Urban Development between the Government of the Republic of India and the Government of the Republic of France;
- that the Prime Minister of India and the President of France had agreed during the Prime Minister of India's visit to France in April 2015, that the subject of Smart Cities was one of the priorities in Indo-French cooperation and that the French authorities would concentrate their attention particularly on the cities of Chandigarh, Nagpur and Puducherry;
- that in the context of the Smart City Mission of the Government of India (launched officially in June 2015) and for the better urban development of the city of Chandigarh, the Agence Française de Développement (AFD) and the Government of the Union Territory of Chandigarh have held discussions to collaborate bilaterally;
- that both the parties are desirous of promoting the establishment and development of closer and long term cooperation in the field of sustainable urban development with a specific reference to the development of the City of Chandigarh.

Have agreed upon the following points taking into account the applicable laws and legal provisions in each country:

ARTICLE I-

The implementation of this present MoU is based on the technical assistance programme and support for technical and financial governance, provided to the Union Territory of Chandigarh, the State of Maharashtra, and the Union Territory of Puducherry, respectively regarding the development of the cities of Chandigarh, Nagpur and Puducherry.

- 1.a. This technical cooperation programme will put at the disposition of the Chandigarh Administration, a pool of French experts from the public sector (French municipalities, local public companies, agencies for urban planning), complemented, if necessary, by experts from the private sector. This pool will consist of experts competent on all the aspects of sustainable urban development: integrated development and urban planning, urban transport, water and waste management, architecture and heritage, renewable energy, energy efficiency, etc.
- 1.b. In a larger context, the pool of experts could rotate like a roster between the three Indian cities -Chandigarh, Nagpur and Puducherry - to which similar French technical assistance will be provided.
- 2. If the city of Chandigarh is selected in the first round, technical support would be provided by the AFD to implement the Smart City Proposal (SCP). This support would cover the following nonexhaustive aspects:
 - 2.a. Technical expertise to strengthen the strategy and management of urban services in the city, covering integrated development and urban planning, urban transport, water stoply, sanitation and waste management, architecture and heritage, renewable energy energy efficiency, etc.

- 2.b. Project management to oversee the detailed project reports and feasibility studies;
- 2.c. Assistance in the creation and structuration of the Special Purpose Vehicle (SPV) to build its strategic management (human resources, finance, potential market assessment, etc.). Specific support can also be provided to draft key contractual documents.
- 2.d. Capacity building for financial management.
- 3. If the city of Chandigarh is not selected in the first round, technical support would be provided to restructure the SCP based on the Central Government's assessment of the first submission.

ARTICLE II-

This framework will be accompanied by, wherever it may be necessary:

- 4. Meetings between the Parties to define the priorities and to carry out annual reviews of the actions undertaken;
- 5. Exchange of visits of delegations of Indian decision-makers to France and French decision-makers to India on the Smart Cities theme (like study tours / technical visits);
- 6. Collaboration between academic and research institutions, exchange of information, documentation and results of research in the field of smart cities;
- 7. Exchange of knowledge technical know-how, institutional cooperation including capacity building, research and development, and commercial relations in the field of urban development with specific reference to Smart Cities programme;
- 8. Other relevant areas mutually agreed upon.

ARTICLE III-

To achieve these objectives:

- 9. The Agence Française de Développement (AFD) will bear the costs of posting French experts in India, as well as their travel costs (air tickets) between France and India and within the Indian Territory, remaining within the activities planned by this MoU and the limits of available funds;
- 10. The Government of the Union Territory of Chandigarh, and other relevant divisions within the Union Territory, will provide resources in support and coordination, remaining within the activities planned by this MoU and the limits of available funds, to include but not limited to:
 - 10.a. Technical information and data related to smart cities planning;
 - 10.b. Staff, logistics, i.e. office working space, accommodation and travel support.

ARTICLE IV-

- 11. As a Memorandum of Understanding, this does not constitute a commitment or obligation of funds by the Parties.
- 12. Cooperation under this MoU is intended to commence upon its signature by all the Parties and will remain in force for a period of three years.
- 13. This MoU may be modified or amended at any time by the prior written consent of one or all the Parties.

- 14. Any of the Parties may revoke this MoU by giving a written notice of thirty (30) days. The revocation will not have any effect on the projects and the works already under implementation, except if a contrary decision is mutually agreed upon by the Parties.
- 15. Any issues arising out of the interpretation and application of this MoU should be settled in good faith by consultation between the Parties.

The implementation of this present MoU is based on the technical assistance programme and support for technical and financial governance, provided to the State of Maharashtra, the Union Territory of Puducherry, and the Union Territory of Chandigarh, respectively regarding the development of the cities of Nagpur, Puducherry and Chandigarh.

This technical cooperation programme will put at the disposition of the Maharashtra and Nagpur Administration, a pool of French experts from the public sector (French municipalities, local public companies, agencies for urban planning), complemented, if necessary, by experts from the private sector. To achieve these objectives:

- 9. The Agence Française de Développement (AFD) will bear the costs of posting French experts in India, as well as their travel costs (air tickets) between France and India and within the Indian Territory, remaining within the activities planned by this MoU and the limits of available funds;
- 10. The Government of Maharashtra, and other relevant divisions within the Government, will provide resources in support and coordination, remaining within the activities planned by this MoU and the limits of available funds, to include but not limited to:
 - 10.a. Technical information and data related to smart cities planning;
 - 10.b. Staff, logistics, i.e office working space, accommodation and travel support.

ARTICLE IV-

- 11. As a Memorandum of Understanding, this does not constitute a commitment or obligation of funds by the Parties.
- 12. Cooperation under this MoU is intended to commence upon its signature by all the Parties and will remain in force for a period of three years.
- 13. This MoU may be modified or amended at any time by the prior written consent of one or all the Parties.

- 14. Any of the Parties may revoke this MoU by giving a written notice of thirty (30) days. The revocation will not have any effect on the projects and the works already under implementation, except if a contrary decision is mutually agreed upon by the Parties.
- 15. Any issues arising out of the interpretation and application of this MoU should be settled in good faith by consultation between the Parties.

MEMORANDUM OF UNDERSTANDING

BETWEEN

THE AGENCE FRANCAISE DE DEVELOPPEMENT

AND

THE GOVERNMENT OF THE UNION TERITORY OF PUDUCHERRY OF THE REPUBLIC OF INDIA

ON TECHNICAL COOPERATION

IN THE FIELD OF SUSTAINABLE URBAN DEVELOPMENT

The Agence Française de Développement, a French public entity governed by French law, and the Government of the Union Territory of Puducherry, of the Republic of India, (hereinafter referred to as « The Parties ») hereby acknowledge the following:

Recognizing:

- that an Indo-French bilateral cooperation agreement has been signed on 5 October 2012 in the domain of Sustainable Urban Development between the Government of the Republic of India and the Government of the Republic of France;
- that the Prime Minister of India and the President of France had agreed during the Prime Minister of India's visit to France in April 2015, that the subject of Smart Cities was one of the priorities in Indo-French cooperation and that the French authorities would concentrate their attention particularly on the cities of Puducherry, Nagpur and Chandigarh;
- that in the context of the Smart City Mission of the Government of India (launched officially in June 2015) and for the better urban development of the city of Puducherry, the Agence Française de Développement (AFD) and the Government of the Union Territory of Puducherry have held discussions to collaborate bilaterally;
- that both the parties are desirous of promoting the establishment and development of closer and long term cooperation in the field of sustainable urban development with a specific reference to the development of the City of Puducherry.

Have agreed upon the following points taking into account the applicable laws and legal provisions in each country:

ARTICLE I-

The implementation of this present MoU is based on the technical assistance programme and support for technical and financial governance, provided to the Union Territory of Puducherry, the State of Maharashtra, and the Union Territory of Chandigarh, respectively regarding the development of the cities of Puducherry, Nagpur and Chandigarh.

- 1.a. This technical cooperation programme will put at the disposition of the Puducherry Administration, a pool of French experts from the public sector (French municipalities, local public companies, agencies for urban planning), complemented, if necessary, by experts from the private sector. This pool will consist of experts competent on all the aspects of sustainable urban development: integrated development and urban planning, urban transport, water and waste management, architecture and heritage, renewable energy, energy efficiency, etc.
- 1.b. In a larger context, the pool of experts could rotate like a roster between the three Indian cities Puducherry, Nagpur and Chandigarh to which similar French technical assistance will be provided.
- 2. If Puducherry is selected in the first round, technical support would be provided by the AFD to implement the Smart City Proposal (SCP). This support would cover the following non-exhaustive aspects:
 - 2.a. Technical expertise to strengthen the strategy and management of urban services in the city, covering integrated development and urban planning, urban transport, water supply, sanitation and waste management, architecture and heritage, renewable energy, energy efficiency, etc.

- 2.b. Project management to oversee the detailed project reports and feasibility studies;
- 2.c. Assistance in the creation and structuration of the Special Purpose Vehicle (SPV) to build its strategic management (human resources, finance, potential market assessment, etc.). Specific support can also be provided to draft key contractual documents.
- 2.d. Capacity building for financial management.
- 3. If Puducherry is not selected in the first round, technical support would be provided to restructure the SCP based on the Central Government's assessment of the first submission.

ARTICLE II-

This framework will be accompanied by, wherever it may be necessary:

- 4. Meetings between the Parties to define the priorities and to carry out annual reviews of the actions undertaken;
- 5. Exchange of visits of delegations of Indian decision-makers to France and French decision-makers to India on the Smart Cities theme (like study tours / technical visits);
- 6. Collaboration between academic and research institutions, exchange of information, documentation and results of research in the field of smart cities;
- 7. Exchange of knowledge technical know-how, institutional cooperation including capacity building, research and development, and commercial relations in the field of urban development with specific reference to Smart Cities programme;
- 8. Other relevant areas mutually agreed upon.

ARTICLE III-

To achieve these objectives:
