### Informational Privacy in India: An Emerging Discourse Taj Vivanta, Subramaniam Bharati Marg, New Delhi November 29, 2018

The last few years have seen a formalisation of the right to informational privacy within India's constitutional framework. While the context to this – the challenge to the validity of the Aadhaar project – has entailed broader issues on delivery of public goods and services, the response to whether an individual can assert control over key informational aspects of her life has become a critical part of our rights jurisprudence. Alongside this evolving constitutional turn, India is also witnessing a legal engineering of sorts in the form of a personal data protection law – a proactive approach towards ensuring that the personal data of Indian residents are handled in a manner respectful of privacy and security interests.

In the light of this background, the Technology and Society Initiative at the Centre for Policy Research, with the support of the Omidyar Network, is organising panel discussions on the above themes where we bring together experts on the subject to engage with embassies, chambers of commerce and research funding organisations located in India.
