# Updates on Privacy by the Centre for Internet and Society

## **PRIVACY IN NEWS**

- Minister of State for Law and IT, PP Chaudhary **informed** the Parliament that the Government of India is in the process of drafting a privacy legislation.
- Multiple incidents with privacy implications around the Aadhaar project have **come in light** after UIDAI detected multiple transactions being done with the same fingerprint.
- Contrasting **judgments** on the right to be forgotten from Karnataka High Court and Gujarat High Court with the former ruling to redact the aggrieved person's name from the order, and the latter holding that there was no legal basis to seek removal of a judgment from the Internet
- SC to decide on setting up of a Constitutional Bench to rule on whether privacy is a fundamental right in the petitions challenging the constitutional validity of Aadhaar project.
