

AGREEMENT

This agreement by and between *Indian Journal of Law and Technology* and *Centre for Internet and Society* is as follows:

I. FINANCIAL ASSISTANCE

CIS will grant the Journal full financial support to conduct the IJLT-CIS Annual Essay Competition for Law Students (*hereinafter called the "Essay Competition"*).

II. GRANT OF RIGHTS

- A. The Journal shall retain the right to select the themes for the Essay Competition and select the panel of judges for the same. However, this shall be subject to mutual agreement between CIS and the Journal.
- B. All rules of the Essay Competition shall be framed by the Journal but in consultation with CIS and shall be subject to mutual agreement between both parties.
- C. The Journal shall have the right to carry out all administrative work in relation to the Essay Competition.


III. TERM

- A. The initial term of this agreement shall be for three years from the date of this agreement and will automatically renew for successive one-year periods unless either party notifies the other of the intention to terminate the agreement in writing at least 180 days prior to the expiration date.
- B. In the event of termination, the Journal shall retain the rights set forth herein. The Journal shall also reserve the right to continue conducting the Essay Competition. In this event, it shall not henceforth be called the IJLT-CIS Annual Essay Competition.

IV. OTHER MATTERS

- A. The copyright for the entries submitted for the Essay Competition shall vest with the author. However, the entries submitted should not have been published elsewhere earlier.
- B. The winning entries shall be published in the Journal if the Journal deems fit.
- C. The essay competition will be launched towards the end of the calendar year and advertised on the journal's website. The essay competition will be completed by the March of the subsequent year and results will be declared by April.
- D. For the initial term of this agreement CIS will pay Rs. 25000 with an escalation of 10% for every year. The cheque will be made out in favour of the Registrar, National Law School of India University and will be handed to a representative of the Journal by the end of September every year, except for the first year.

This agreement will be construed in accordance with the laws of the Republic of India and constitutes the full and complete understanding of both parties regarding the subject.
